

**City of Vero Beach Recreation Department
Grand Pavilion and Picnic Pavilion Rental
Alcoholic Beverages Clause**

The consumption of alcoholic beverages is based upon a written permit that must be obtained and signed at the Vero Beach Recreation Administration/Community Center building prior to the scheduled event. An alcohol fee of \$250.00 and a refundable \$200.00 damage deposit are required.

Any renter who has an event at the Grand Pavilion or the Picnic Pavilion with 150 guests or more and where alcoholic beverages are served will pay two (2) City of Vero Beach police officers to monitor the event.

If at any time the Police Officers feel the event is becoming dangerous or out of control, they shall have the right to call for back-up, stop the event and clear the pavilion areas of all persons. Should this occur the renter will lose all fees and deposits paid for the event. Activities which may cause this to happen include underage drinking and guests becoming unruly or intoxicated.

There will be no drinking of alcoholic beverages allowed outside of the pavilion structure. This will be considered as in the park, and is against the law.

Beer must be in cans or in a keg (served in plastic cups), NO bottles.

PERMIT FOR THE CONSUMPTION OF ALCOHOLIC BEVERAGES BY CIVIC ORGANIZATIONS AND CONTRACTED FUNCTIONS IN CITY OWNED BUILDINGS

As a consideration for the issuance of this permit, the applicant agrees as follows:

- 1) Applicant hereby certifies that all officers agents, employees, volunteers, or members of Applicant’s organization, or any other persons who will serve or dispense alcoholic beverages pursuant to this permit, are familiar with applicable laws and ordinances relating to dispensing and/or consuming alcoholic beverages, and that all persons serving alcoholic beverages pursuant to this permit will operate in conformance with those laws and ordinances.
- 2) The Applicant fully assumes the burden of providing security and ensuring that its agents, employees, volunteers, members, and guests remain orderly during the Applicant’s occupation of the premises.
- 3) Applicant agrees to dispense alcoholic beverages for a period of time not to exceed the time set forth herein.
- 4) Consumption of alcoholic beverages under this permit shall be limited to the confines of the rental structure. Consumption or possession of alcoholic beverages beyond this is strictly prohibited. This is against the law.
- 5) Applicant agrees to hold the City of Vero Beach harmless from any and all liability for any damages, claims, or causes of action which may arise out of the Applicant’s occupation of the premises described herein. The applicant agrees to defend the City of Vero Beach in any action filed in any court, in the City’s name if applicable, and to pay any judgments, costs, and/or fees resulting from such actions.
- 6) Applicant understands and agrees that the City of Vero Beach may revoke the license to occupy the premises granted herein, without notice, if City staff is notified that the premises are being utilized in a manner inconsistent with this permit.
